Participating agencies must nominate an individual in the agency to administer the subscription. This would include distributing the publications and managing the registrations for courses and events. This will allow agencies to control how the benefits are distributed.

Subscriptions run from January to December. Registration forms are valid for the current year only.

Agencies will be provided with personalised subscription registration forms. The number of forms held by the agency will reflect the level of subscription taken up (Senior Partner, Associate Partner, Partner).

Each registration form will be individually numbered for ease of tracking. In order to secure registration for an event or course the ORIGINAL numbered registration form must be returned to IPAA NSW.

Agencies are encouraged to fax registration forms to secure tentative bookings. However, a booking will not be confirmed until the original subscription registration form is received. If the subscription registration form is not received, the individual will be charged at the non member rate for the course or event.

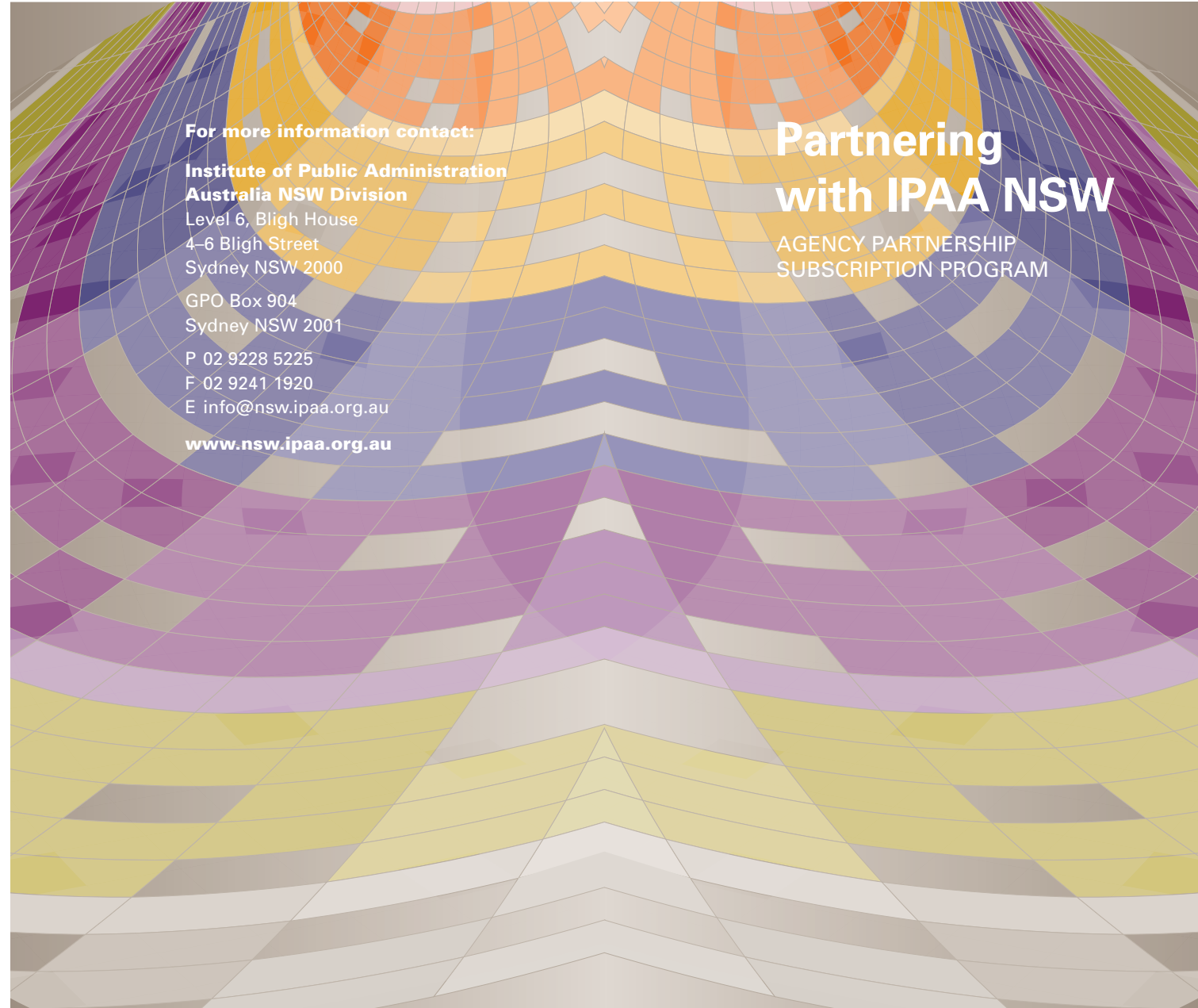
